Additional Municipality tax

The increment of € 2,50 , suspended on 23AUG for the departure between 01SEP16 and 31DEC16, has now been cancelled with effect 1JAN17.

The cancellation is included in the Budget Law 2017 , approved by the SENATE on 7DEC16 and published on the Official Gazette on ...

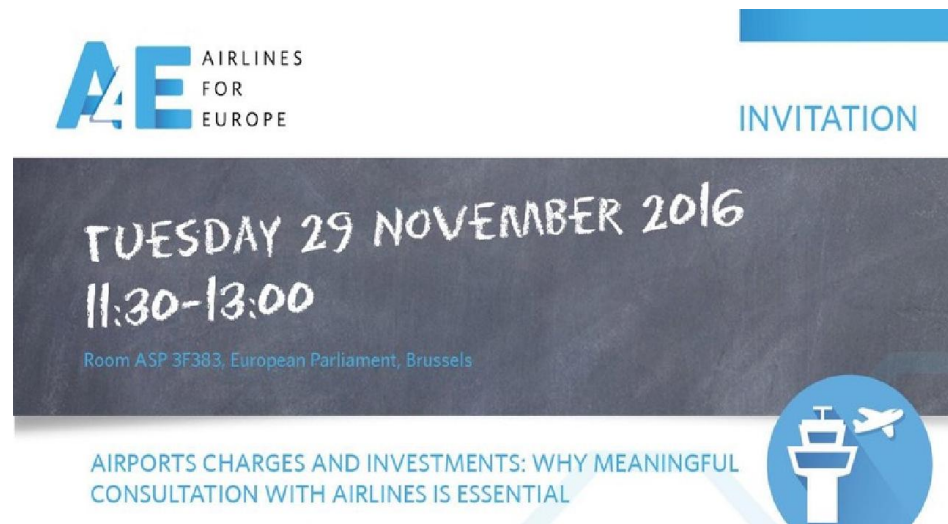
ENAC will notify IATA – through AZ - for the necessary updating of the TTBS (Ticket Tax Box Service)

For the departures after 1JAN17 the Carriers have collected € 2,50 , but may be eventually billed €2,42

Court Decision of 30SEP16 on the “No-show rule

The cancellation by the Carrier of the return and/or subsequent sectors in case of no-show has been deemed illegitimate by the Court.

A4E workshop on airport charges



EU set to kick-off a review of the Airport Charges Directive 2009.

Lack of transparency and meaningful consultation must be addressed in several Member States.

EU Commission (DG MOVE) still investigating the role of ENAC.

ART

REGULATORY MODEL :

- Voting system
- Predetermined parameters
- No incentive for the airports to become efficient
- Single till

OVERSEEING CHARGES 2017 :

- IBAR views favourably the existence of an independent regulatory Authority , however its scope and prerogatives must be clearly affirmed.
- Airlines may end paying their contributions twice : both directly and through the airports charges.

Cluster Cargo Aereo

CCA will set up an independent academic Panel monitoring Cargo activities in Italy.

The Panel will produce studies outlining the value for the National economy of Air Cargo/Logistics and comparisons with the best practices in Europe.

The Associations will participate in the Panel steering committee.

The Associations will not participate directly in the funding of the Panel. Sponsorship opportunities for the interested Carriers will be available.

Consultations on Airport charges

FCO / CIA

The Associations have submitted a recourse to ENAC , decision within 25 days .

VCE

Final proposal approved by ENAC , deadline for a possible recourse to the Administrative Tribunal : 60 days from the publication.

CAG

ART has accepted the ASSAEREO/IATA/IBAR recourse.

The Airport Operator must submit a revised charges proposal .

The old charges remain effective until the end of the procedure.
