

DECLARATION FOR ENTRY IN ITALY - FLIGHTS COMING FROM U.K.

Having regard of the measures provided for by the Prime Minister's Decree issued on 14.01.2021 (specifically articles 6, 7, 8 and 9) in order to prevent the spread of the "COVID-19" pandemic, as well as by the Ordinance of the Minister of Health issued on 09/01/2021, that limits entry into the Italian national territory and air traffic coming from the United Kingdom of Great Britain and Northern Ireland is restricted, and in case, it is allowed exclusively according to the following rules:

- a) Obligation to show to the carrier, upon boarding, the certification of having undergone a molecular or antigenic test (swab) within 72 hours prior to entry into the national territory;
- b) Obligation to undergo molecular or antigenic tests (swab) upon arrival at the airport, or within 48 hours of entering the Italian national territory. In case of a direct flight from the United Kingdom of Great Britain and Northern Ireland, the swab must be carried out exclusively at the airport;
- c) Obligation to undergo health surveillance and fiduciary isolation for 14 days, regardless of the outcome of the test.
- d) As for aircraft crew and haulage workers, it is required only the molecular or antigen test (swab) to be carried out upon arrival at the airport, or within 48 hours from entry into the Italian national territory, without the need to carry out the period of fiduciary isolation
