

Ministry of Health Ordinance published on the official Gazette dated April 17th, 2021

Extract & Courtesy Translation

••••

Art 1

- 1. "... whoever enters the national territory for any period of time from States or Territories included in the "C", "D" and "E" lists of the Attachment 20¹ to the DPCM dated 02MAR21 is obliged to present to the Carrier or to any subject in charge of the controls upon boarding a certification of having undergone a molecular or antigenic test to be carried out by a swab in the 48 hours preceding the entry in the national territory.
- 2. Provided that no covid19 symptoms arise and without prejudice to the self-declaration obligations, the prescriptions laid out in paragraph 1 above do not apply to:
 - a) cockpit crews
 - b) cabin crews
 - c) movements to/from the Countries listed under "A" in the Attachment 20.

f) whoever enters Italy for a period not exceeding 120 hours for proven work, health or absolute urgency reasons, with the obligation, upon expiry of the above mentioned deadline, to leave immediately the national territory or, alternatively, to begin a period of fiduciary self-isolation.

g) whoever transits , by private means of transport , the italian territory for a period of time not exceeding 36 hours with the obligation , at the end of such period , to leave immediately the national territory or , alternatively, to begin a fiduciary isolation period.

I) cross-border workers exiting/entering the national territoy for proven work reasons and for the consequent return to their homes, residences and dwellings.

m) the staff of firms and outfits with head offices or registered local offices in Italy with regard to movements abroad for proven work exigencies not exceeding 120 hours.

o) pupils and students for the attendance of courses in a State other from their homes, residences, dwellings to which they return at least once a week.

3. This Article will apply as of **April 19th**, **2021**

Art 2

1. The sanitary surveillance and fiduciary isolation period for the persons who have stayed or transited, in the 14 days preceding their arrival in Italy, in States or territories listed under "E" in the Attachment 20 to the DPCM of 2MAR21, is hereby determined in **10 days**, with the obligation to carry out a molecular or antigenic test, by means of a swab, at the end of such period.

Art.3

1. Whoever enters the national territory for any length of time arriving from the States and territories listed under "B","C", "D" and "E" in the Attachment 20, before his/her entry in the national territory must fill in a specific localization form in digital format, with the terms and conditions to be announced by an ad-hoc circular of the General Directorate for Sanitary Prevention, and provide proof to the carrier or whoever is in charge of performing controls. Such digital form supersedes the paper declaration to be used solely in case of technological impediments.

Art 4

1. ... the entry in and the transit through the national territory by the persons who have stayed in or transited through Brazil in the preceding 14 days is forbidden (with exceptions)
